1. Gifted Education Advisory Committee

Gifted Education Advisory Committee

The Ohio Department of Education (ODE) is convening an advisory committee to review department recommendations addressing recent legislation in HB 1, including:

- development of administrative rules regarding the expenditure and reporting of gifted funds; and
- development of a performance indicator reflecting the level of services provided to and the performance of gifted students by December 31, 2011.

The committee will be comprised of members from several organizations that represent a broad base of stakeholders (organizations listed on right). The organizations have been asked to nominate an individual to participate as a member of this committee. Nominees should have a strong interest in the education of gifted and advanced students and should be able to serve as a representative of the organization.

The organizations invited to participate have until February 15 to nominate an individual to serve on the committee.

2. Call for Credit Flex Case Studies

Senate Bill 311 (the Ohio Core legislation) raised the graduation requirements for high school students, with the goal of increasing the number of students who are ready to meet the demands of our global and technological age. It included among its several provisions, credit flexibility (more information can be found by visiting education.ohio.gov and searching the term "credit flex"). If your district is currently utilizing or planning for credit flexibility in a way that is particularly beneficial for gifted students, we would like to hear from you. This could include topics such as educational options (particularly in the arts), testing out, acceleration, as well as credit flexibility more broadly. An interdepartmental team is at work at ODE on guidance documents and would like to feature case studies of the ways in which credit flexibility can be useful in broad areas. 3. Gifted Education Audits

In an effort to be more efficient and less intrusive to districts, the Office for Exceptional Children (OEC) will be incorporating particular aspects of special education monitoring and gifted education monitoring into the Program Audit Compliance Tracking System (PACTS) utilized by ODE's Office of Federal Programs.

As part of this process, approximately 40 districts this year will participate in onsite reviews related to federal programs, special education and gifted education.

The Office of Federal Programs PACTS contact person will be taking the lead for the PACTS process. In addition, OEC will be assigning a consultant that will provide technical assistance, if requested, related to the special education and gifted education reviews.

Districts will receive additional information regarding the activities and materials that will need to be prepared prior to the visit in addition to what districts can expect during and after the visit.

4. Wheel of Learning for Students Gifted in Fine Arts Available Online

The *Wheel of Learning for Fine Arts* is a professional development tool developed by a team of arts specialists, professional artists and gifted educators. The purpose of the tool is to provide examples of service settings, instructional strategies and resource options that will guide educators of students who are gifted in the arts. The tool will:

- Guide Ohio educators in the selection, preparation and development of differentiated education plans, materials and curriculum;
- Guide gifted educators in creating a written education plan for a student gifted in the visual and performing arts;
- Guide collaboration among educators serving students who are gifted in the visual and performing arts;
- Guide high quality professional development (HQPD) for Ohio educators regarding curriculum and instruction for students gifted in the visual and performing arts.

Online Educational Options

To help address requirements of the new credit flexibility policy and expand access to advanced and specialized learning options for students, Learning|Connective, a non-profit educational organization, is attempting to assess interest on the part of districts in participating in a co-op pooling students and teachers to offer Web-facilitated asynchronous courses on topics individual districts cannot typically offer due to lack of local critical mass. The goals of this project would be to replace learning opportunities lost with the cancellation of the Ohio Summer Honors Institutes, help districts comply with credit flexibility requirements, and expand curricular offerings for students while minimizing district costs and the need to outsource instruction to for-profit and out-of-state providers.
